



Summer School 2025



Remediation (making up a D or F grade):

- If your student received a D or F in a core subject, your student will be enrolled in in-person, Traditional Summer School on campus. More info regarding Traditional Summer School will be posted on the Alternative Education site in Spring 2025: <https://www.chino.k12.ca.us/domain/716>
- If you are unable to attend in-person for Traditional Summer School, please see your counselor **BEFORE 4/17/25.**

Impacted Schedule:

- (1) You must be currently enrolled in 2 or more impacted programs/classes (AVID, BAHT, HSA, Leadership, Athletic PE, Band, Choir, Theater, Cheer, Spirit, or Dance)
- (2) Your schedule is impacted due to academies and enrolled programs (not due to preferred electives) and the course you are requesting to take cannot fit during your 4 years at CHHS along with your 2 or more programs/classes.
- (3) Unless the course you are requesting to take is for a graduation requirement, it will not be added to CHHS transcript. (Graduation Requirements: <https://www.chino.k12.ca.us/Page/15056>)
 - a. Any course taken will not qualify you for Awards (i.e. Seal of Biliteracy, Distinguished Honors, Grad w/Honors, etc.)
 - b. When applying for colleges, you will need to submit external institution's transcript when reporting courses taken
 - c. If you have already met or will meet the requirements for graduation with other courses taken at CHHS, this course will not be added to CHHS transcript.

Enrichment:

- Courses **will not** be placed on your CHHS transcript & you do not need to fill out an Alternative Credits form. Transcripts from external institutions should be submitted separately when applying for colleges. Any courses taken for enrichment will not qualify you for [CHHS Awards](#) (i.e. Seal of Biliteracy, Distinguished Honors, Grad w/Honors, etc.)

Chaffey Dual Enrollment Summer Courses:

- Courses may be taken without Alternative Credits form approval. Transcripts from Chaffey College should be submitted separately when applying for colleges. *Courses listed on the District's page (See CVUSD website > [Dual Credit Courses](#)) are eligible for general elective credit. See District Course Agreement for Dual Enrollment to complete and turn into Records office.
- It is the responsibility of the student to enroll him/herself in [Chaffey Dual Enrollment](#) courses.

*****Alternative Credits Form: Students should only submit an Alternative Credit form if you are requesting external credit approval for remediation or impacted schedule.**

- Any student who plans to take summer school outside of the classes offered by Chino Valley Unified School District will need to get approval from counselor and administration (Alternative Credits Form) **prior** to taking the course. **Deadline to submit Alternative Credits Form will be 4/17/25 (Friday).** No exceptions. Counselor & admin approval for summer school only applies to current CHHS students. **Any incoming student (not a current CHHS student) will need to seek approval from their own school/counselor.**
- It is the responsibility of the student to enroll at external institutions if Alt. Credit approval is given.
- Anyone attempting to take a summer school class outside of the classes offered by Chino Valley Unified School District without obtaining prior approval from a counselor and administrator will be denied the ability to add the credits for that class to their transcripts.
