Why is my child in the EL program?

English Learner – A student who enrolls in a California school beginning in any grade level, transitional kindergarten through grade twelve, has a language other than English identified on the Home Language Survey, and upon assessment, obtained a level of English proficiency that indicates programs and services are necessary. Students identified as English learners receive programs and services until they meet the reclassification criteria pursuant to Education Code (EC) Section 313.

Addressing Needs of EL Students

- All English Learner (EL) students, regardless of ELPAC levels, must have Designated ELD instruction until reclassification
- The ELD component of the Connections adopted curriculum addresses all proficiency levels
- Read 180 can be used to supplement the curriculum
- Integrated ELD is provided to ELs throughout the school day and across all subjects by all teachers of ELs

What is the English Learners Advisory Committee (ELAC)?

- Parent members are parents of English Learners (ELs).
- Parents of ELs constitute at least the same percentage of the committee membership as their children represent of the student body.
- This first meeting should be to clearly communicate to members the roles/responsibilities of ELAC and to elect DELAC representative.
- The ELAC shall be responsible for assisting in the development of the school-wide needs assessment and ways to make parents aware of the importance of regular school attendance
- Advise principal and staff in the development of a site plan for EL's and submitting the plan to the SSC for consideration of inclusion in the SPSA.



- Address allegations of unlawful discrimination, harassment, intimidation, and bullying, and complaints alleging violation of state or federal laws governing educational programs, the charging of unlawful pupil fees and the non-compliance of our Local Control and Accountability Plan (LCAP)
- Complaint forms are available at each school site and district office.
- The complaint shall be initiated no later than six months from the date when the alleged discrimination occurred, or six months from the date when the complainant first obtained knowledge of the discrimination
- a written report of the district's investigation and decision (findings) within 60 days of the district's receipt of the complaint

Summative ELPAC Scores:

Results are reported at four performance levels:

- Level 4
 Well Developed
- Level 3
 Moderately Developed
- Level 2
 Somewhat Developed
- Level 1
 Beginning to Develop





Reclassification



- The student must have an overall score of 4 on the ELPAC
- Student must also score standard met or standard exceeded in Language Arts on the SBAC/ESA
- Other documentation that supports recommendation such as report card grades, writing sample, performance on summative and formative assessments
- Agreement by parent, teacher, and school administrator
