## CHINO VALLEY UNIFIED SCHOOL DISTRICT APPLICATION FOR MEASURE G, INDEPENDENT CITIZENS' OVERSIGHT COMMITTEE

The Board of Education of the Chino Valley Unified School District is seeking qualified, interested individuals to serve on a committee of community leaders which will serve as the Independent Citizens' Oversight Committee ("COC") for the implementation of the District's Measure G school facilities bond program.

#### **Proposition 39 Bond Election**

On November 8, 2016, voters residing within the Chino Valley Unified School District passed Measure G. Measure G is a \$750,000,000 bond measure that authorizes funding for needed repairs, upgrades, and new construction projects to the District's schools. Proposition 39 required a 55% supermajority for approval; Measure G was passed by 55.99%.

#### **Establishment of a Citizens' Oversight Committee**

After a bond authorized under Proposition 39 is passed, state law requires that the Chino Valley Unified School District Board appoint an Independent Citizens' Oversight Committee to work with the District.

## **Committee Responsibilities**

In accordance with Education Code Section 15278(b), the Citizens' Oversight Committee shall:

- Inform the public concerning the District's expenditure of Measure G bond proceeds;
- Review expenditure reports produced by the District to ensure that Measure G bond proceeds were expended only for the purposes set forth in Measure G; and
- Present to the Board in public session, an annual written report outlining their activities and conclusions regarding the expenditure of Measure G bond proceeds.

The Bylaws which govern the Citizens' Oversight Committee are attached to this Application.

#### **Qualifications and Appointment of Committee Members**

The Committee shall consist of at least seven (7) members, appointed by the Board from a list of candidates submitting written applications. Committee members will be selected based on their qualifications per the criteria established by Proposition 39.

### Time Commitment and Term

Initial appointments will be staggered, such that some of the initial appointees will be appointed to serve one full two-year term. The other initial appointments will serve a one-year term, but will be eligible for reappointment by the Board for a second and third two-year term.
