

# Ayala High School Parking Lot Contract

The Board of Trustees of Chino Valley Unified School District has provided the students of Ayala High School with a parking area. By school policy, use of the parking lot is considered a student privilege and not a right. A privilege of this kind assumes obligations and responsibilities on the part of the recipient, in this case, the student driver. Ayala High School, therefore, reserves the right to suspend or revoke on-campus parking privileges of any student who abuses driving and parking regulations. Further, by entering any on-campus parking lot, the person driving any vehicle is deemed to consent to complete search of the vehicle, all its compartments and contents, by school officials or law enforcement personnel for any reason whatsoever. This notice applies to all vehicles of any type and is in force 24 hours a day.

Parking lot regulations are not made to needlessly censor or prohibit student activity. On the contrary, these regulations should safeguard the health and property of the student driver, as well as to protect the right of other drivers, pedestrians, and homeowners in the immediate vicinity of the school.

The following regulations will be strictly enforced:

1. A student driver must download the application forms from the Ayala High School webpage outlining the responsibilities, rules, and regulations concerning the parking lot. This contract must be downloaded, read, and signed by the student and his/her parent or guardian.
2. Parking permits, at a cost of \$20, are good for the entire school year and will be issued to **SENIORS and JUNIORS with valid DL's only**. Permits must be purchased online, through the Ayala webstore. Please contact Nichole Vicario in the Admin building if you have questions.
3. A student-driven car must have an official Ayala parking permit hanging from the rearview mirror (permit # must be facing outward).
4. Cars that do not have the parking placard properly displayed will be cited by Campus Security.
5. **A replacement parking permit will be issued at a cost of \$20 for lost or destroyed permits.**
6. Reckless driving and excessive speed in the parking lot or in the vicinity of the school will not be tolerated and will result in immediate loss of parking lot privileges. The speed limit in the lot is 5 MPH.
7. Once a car is driven onto the lot, it must be parked. Cruising in and out of the lot or in front of the school is not permitted.
8. Students are to leave the parking lot area as soon as their cars have been parked.
9. The lot is off limits during the school day. Students are not allowed to eat lunch in their cars or work on their cars during this time.
10. Student drivers who must leave during the school day for medical or family business must bring a note from their parents and follow regular attendance procedures.
11. Students are not permitted to park in **faculty, staff, visitor, or reserved parking stalls**.
12. Cars should be locked at all times while parked at school. Ayala High School and the Chino Valley Unified School District are not responsible for the theft, damage, or loss of property.
13. All vehicles **MUST** park in only one space; vehicles that are taking up more than one space are subject to receiving a citation. Do not park in restricted parking zones (red or yellow curbs) and do not block other vehicles. No parking is allowed in Handicapped parking without a valid Disabled Person Placard.
14. **PLACARDS ARE NOT TRANSFERRABLE**. Violation may result in the loss of Parking Lot privileges and/or suspension.
15. Forged off-campus passes or parking permits will result in loss of Parking Lot privileges and/or suspension may result.
16. A parking permit allows students to park in the student parking lot; however, it does not guarantee a parking space.
17. Student parking is a privilege conditional upon appropriate attendance and behavior at school. Administration reserves the right to revoke student permits for disciplinary and attendance related issues.
