OF THE BOARD OF EDUCATION ACTING AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT 1 OF THE CHINO UNIFIED SCHOOL DISTRICT DETERMINING TO CEASE LEVYING ITS SPECIAL TAX

WHEREAS, pursuant to the Mello-Roos Community Facilities Act of 1982, as amended (Act), the Board of Education (Board) of the Chino Valley Unified School District (District), established Community Facilities District 1 of the Chino Unified School District (CFD), and pursuant to an election held on December 16, 1986, levied a special tax in accordance with Ordinance 87-23 (Ordinance) and a rate and method of apportionment (Rate and Method); and

WHEREAS, in March 1987, the CFD issued its \$1,665,000.00 Series 1987 Bonds of Community Facilities District 1 of the Chino Unified School District (1987 Bonds); and

WHEREAS, the 1987 Bonds have been defeased and retired and the CFD has no further debt obligations; and

WHEREAS, the financial obligations of the property owners within the CFD under the Rate and Method have been fulfilled; and

WHEREAS, pursuant to the Rate and Method, the CFD now desires to extinguish and cancel all CFD liens on property within the CFD;

NOW, THEREFORE, THE BOARD OF EDUCATION OF THE CHINO VALLEY UNIFIED SCHOOL DISTRICT, ACTING AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT 1 OF THE CHINO UNIFIED SCHOOL DISTRICT, DOES HEREBY RESOLVE AND DETERMINE AS FOLLOWS:

Section 1. The above recitals are true and correct.

<u>Section 2.</u> The special tax authorized to be levied by the CFD is no longer needed to pay (a) the principal and interest on debt incurred in order to construct facilities or (b) the costs and incidental expenses of services or of the construction of the facilities, under authority of the Act and the Ordinance.

Section 3. The CFD hereby declares that the special tax authorized to be levied within the CFD shall cease to be levied and the CFD shall have no further authorization to levy any future special tax.

Section 4. A final accounting of the funds of the CFD shall be conducted and the Secretary or its designee is hereby directed to send a request to the County of San Bernardino Auditor-Controller to remit any and all funds relating to the Bonds and the CFD to the CFD and to disburse said funds as appropriate and lawful. After payment of

all administrative costs of the CFD, any funds remaining from the Bonds shall be used for any lawful purpose of the CFD, including public capital improvements and facilities.

<u>Section 5.</u> The Secretary is hereby directed to cause a notice to be recorded in the office of the San Bernardino County Recorder which shall state that the obligation to pay the special tax has ceased and the liens imposed by the recorded Notices of Special Tax Lien, as amended, are extinguished.

Section 6. This Resolution shall take effect immediately.

WHEREAS, in December 1988, the CFD issued its \$1,025,000.00 Series 1988 Special Tax Bonds (1988 Bonds); and
