- Member Communications
  - Lou Alfonso commented on his focus on CCTV, security, and surveillance and that these systems are only as good as the hardware and software, and that the software needs updates and hopes the District will ensure the updates are implemented regularly. He also mentioned test scores need to be improved and that there must be parental involvement to help the schools improve student test scores.
  - May Evangelista was thankful to serve on the COC and said she attended an event in the new gymnasium at Chino HS and that it was a beautiful facility.
  - Carol Cole thanked everyone for the opportunity to serve on the COC and would be watching from afar.
  - Debra Dorst-Porada said that the city of Ontario recently passed their Measure Q bond which will help them fund storm drains and street improvements among other things throughout the city.
  - Michael Leeming said he thinks the new Chino HS campus is very well done and that it looks more like a university than a high school campus.
  - Art Bennet thanked staff for quick answers to his questions and wants to reassure the public that proper oversight of bond funds is happening by both the committee and District staff. He believes every student in the district should have nice school facilities and that CVUSD is doing things right. He agreed that test scores are very important to monitor and that he has confidence that the District will continue to ensure all the right things are in place with the curriculum to continue to raise test scores every year.
  - Kevin Cisneroz thanked everyone for the opportunity to serve on the committee and that he enjoyed seeing things come to fruition from the early bond planning stages to the completion of Chino HS, all of the other projects and modernized schools as well as the construction of the new school in the Preserve.
