Funding Sources for Support Services

Below is a list of funding sources that CVUSD utilizes to fund the HOPE support services program. Different funding streams come together to support different elements of the program, different staff positions, and different programs, all with the goal of improving educational outcomes for children, 0-21, meeting basic needs, and ensuring their success in the classroom.

We offer this list as an example of aggregating funds from different streams to strengthen and support existing efforts. There is money allocated to meet the targeted needs of students. By leveraging these funds, we can provide multilayers of support for students and families.



LCAP or Local Control Accountability Plan is a statewide 3-year planning tool for California local educational agencies to set goals, plan actions, and leverage resources to meet those goals to improve student outcomes. The LCFF creates funding targets based on student characteristics and provides greater flexibility to use these funds to improve student outcomes. LCFF Whole Child resources support schools in creating an environment where all students are safe, engaged, supported, challenged and healthy. TYKES is a First 5 San Bernardino County grant awarded to provide Nurturing Families program education and intensive case management to families with children 0-5. The Commission contracts with agencies to provide direct services to young children and their families throughout the county. Funded programs align with the First 5 Strategic Plan and collectively help achieve the desired results of getting children ready to succeed in school, ensuring children are safe and healthy, and developing healthy, nurturing, self-sustaining families. Title I is a federal funding stream that supplements how much money each state allocates for schools. Title 1, Part A Reservation funds include poverty, homelessness, living in staterun institutions, living in isolated rural districts, and those still learning the English language. Allocating district Title I funds toward support services leverages these funds to provide the intensive services that MV-eligible students need to overcome barriers and succeed in school. EHCY or Education for Homeless Children & Youth is a 3-year state of California (CDE) grant meant to serve homeless students and their families. We have had the grant consistently for the past years. CVUSD uses these funds to primarily fund our MV program manager position. ARP I & II or the American Rescue Plan required the U.S. Department of Education (ED) to reserve \$800 million to support efforts to identify homeless children and youth, and to provide such youth with comprehensive, wrap-around services that address needs arising from the COVID-19 pandemic and allows them to attend school and participate fully in all school activities. California has been allocated \$98,757,695 for ARP-HCY funds. These funds may be used in accordance with all allowable uses under the McKinney-Vento Education for Homeless Children and Youth programs. However, they expire in October 2024. Learn more

HIP or Homeless Innovative Program is a two-year grant designed to have LEAs or COEs scale up their innovative practice(s) and develop an MIP toolkit. The MIP is a practice that has been developed to meet an identified need to improve educational experiences for infants, preschoolers, students, and students transitioning to college, who are experiencing homelessness. Did you know?

The initial funding for CVUSD came through a First 5 grant awarded to the Focus on Youth Collaborative to invest in children 0-5. Although funding priorities have shifted through the years, CVUSD has received consistent funding through various cycles to support its nurturing families program, allowing HOPE to build relationships and serve families even before children start school and investing in that 0-21 pipeline of services.
