Exceptions to Timeline

15 days

Not counting calendar days between regular school sessions/term or days of school vacation in excess of five school days.

When referral is made in the last ten days of school, the proposed assessment plan must be provided within the first ten days of the start of the new year.

60 days

Not counting calendar days between regular school sessions/term or days of school vacation in excess of five school days.

When referral is made 30 days or less prior to the end of the regular school year, IEP must be developed within 30 days after the start of the subsequent regular school year.

When a referral is made prior to the last 30 days of the school year, the IEP must be
