**SUBJECT: IN-PERSON SCHOOL REOPENING**

**BACKGROUND**

At its February 18, 2021 regular meeting, the Board discussed the new criteria for eligibility to reopen for in-person instruction for grades TK (Transitional Kindergarten)-6. Students in grades TK-6 may return to in-person instruction after a county in Purple Tier status sustains an adjusted Covid-19 case rate below 25 cases per 100,000 for five consecutive days. In addition, the Covid-19 Safety Plan must be approved by the State Safe Schools for All Team and the local health officer at least 5 days prior to providing in-person instruction. Chino Valley Unified School District has met the criteria.

Additionally, students in grades 7-12 are not eligible to return for in-person learning until the County is officially in the Red Tier status for five consecutive days.

If the Board votes to approve the reopening plan for grades TK-6, schools will transition as early as March 3, 2021. If the Board votes to approve the reopening plan for grades 7-12, the Superintendent will have the authority to reopen schools when the County is officially in the Red Tier status for five consecutive days.
