President Gagnier adjourned to closed session at 5:00 p.m. regarding anticipated litigation: one possible case; a student discipline matter; a student readmission; and public employee appointment: elementary and high school and junior high school assistant principals.

**I.B. RECONVENE TO REGULAR OPEN MEETING – 6:00 P.M.**

1. Report Closed Session Action

President Gagnier reconvened the regular meeting of the Board of Education at 6:00 p.m. with Bridge, Cruz, Na, Schaffer, and Gagnier present. The Board met in closed session from 5:00 p.m. to 5:38 p.m. regarding anticipated litigation: one possible case; a student discipline matter; a student readmission; and, public employee appointment: elementary and high school and junior high school assistant principals.

The Board appointed Patricia Vega-Jeter as assistant principal of Cal Aero K-8 effective February 4, 2022, by a unanimous vote of (5-0) with Bridge, Cruz, Na, Schaffer, and Gagnier voting yes. No further action was taken that required public disclosure.

Esther Kim spoke about student issues; exploring career paths; and acknowledged senior student athletes.

Brenda Walker, A.C.T. President, thanked A.C.T. unit members who participated in the SB 328 survey; thanked the District for including A.C.T. leadership in the SB 328 Task Force; said the decision to change start times originated at the state level; acknowledged CVUSD employees for working through the current difficulties; spoke about school counselors; said the Association has consulted with the District regarding testing all educators for COVID-19, and the District's response is that it will continue to follow all state/county/local guidelines; and requested that the Board grant A.C.T. a seat at the table during the LCAP writing process.

Barbara Bearden, CHAMP President, spoke about potential counselors, and thanked staff for participating in the interview process; and announced a zoom CHAMP meeting scheduled for Friday, February 4 at 6:30 a.m.

After discussion, a roll call vote was taken and the motion failed (2-3, Bridge, Cruz and Na voted no) to select Scenario 3. Moved (Bridge) seconded (Gagnier) for Scenario 1. After discussion, a roll call vote was taken and the motion carried (4-1, Schaffer voted no) to select Scenario 1 (student representative voted yes). Moved (Bridge) seconded (Na) motion carried (4-1, Schaffer voted no) to adopt Resolution 2021/2022-53, Approving Adjusted Trustee Area Boundaries. (student representative voted yes)

The remainder of comments from the public on items not on the agenda were heard before item V.: Sonjia Shaw, Angela Romero, and Adam Hoover addressed the Board in opposition to mandates associated with COVID-19.

## **V. COMMUNICATIONS**

### **BOARD MEMBERS AND SUPERINTENDENT**

Mr. Schaffer thanked everyone who served on the SB 328 Task Force; and asked Dr. Enfield for the RFP timeline/process for vendors providing the same services related to city of Chino contracts, which the Board will be considering over the summer.

Mr. Bridge thanked everyone who served on the SB 328 committee; spoke about National Signing Day for high school athletes, and the need for the District to recognize those student athletes; and announced the birth of his grandchild.

Mr. Cruz spoke about masks negatively impacting students' emotional well-being; read a parent email asking that the Board give parents masking choice; spoke mask mandates, guidelines, and CDC updated recommendations; spoke about the negative impact masking has on IQ levels and oxygen levels; shared information from the military information database; and said he is submitting a resolution at the next Board meeting regarding mandated COVID-19 vaccines for students.

Mr. Na thanked parents who brought the flag to the meeting; thanked security personnel and SROs; said he will bring a resolution prohibiting disciplinary actions against students for not wearing masks or not having vaccination; said a recent study showed that masks only prevent 2% spread of anything; said teachers/staff are often sent home during COVID contact tracing and are using their own sick leave, and asked Dr. Enfield to work with union leadership; thanked the community for coming to the meeting despite the weather; and encouraged community members/viewers to join the Parent Advocacy Group.


Superintendent Enfield acknowledged the work that school counselors do; thanked the SB 328 Task Force for their work and volunteering their time; and said that the District has been working with CSEA and A.C.T. on COVID sick time provisions.

President Gagnier requested and received consensus for the student representative to make additional comments. Ester Kim spoke about being involved as stakeholders.

President Gagnier spoke about Board meetings and community involvement; and spoke about her role as Board president related to how meetings are conducted.
