#### Third Quarter Report of The Citizens Oversight Committee 2007/2008 School Year

The Citizen's Oversight Committee, herein referred to as the Committee, is currently comprised of 13 members: Tom Haughey, representing the City of Chino; David Black, representing a taxpayers' organization; Kevin Cisneroz, an at-large member; Edgar Gray Jr., representing a senior citizen organization; Jamie Harwood, representing a business organization; Natalie Sanders, representing a parent-teacher association; Julie Allen, an at-large member; Roman Nava, an at-large member; Steve Elie, a parent member; Christina Gonzales, an at-large member; Alan Wapner, representing the City of Ontario; Tina Javid, representing the Chino Valley Chamber of Commerce; and Peter Rogers, representing the City of Chino Hills.

Sandra Chen, Michael Chapko, Iris Chu, Greg Stachura, and Laurie Trimbach served as district representatives to the committee.

The Committee met one time during the quarter, on January 14, 2008. The meeting minutes are attached to this report.

Julie Allen and Roman Nava continue to serve as the Chairperson and Vice-Chairperson of the Committee, respectively. The position of Secretary remains vacant. Committee member Kevin Cisneroz has been effectively managing the Committee Website, including posting the member information, meeting minutes, and construction updates.

During the January 14<sup>th</sup> meeting, Ms. Chen presented the latest Measure M expenditure report to the Committee. As of November 30<sup>th</sup>, \$107.9 million had been expended, leaving a balance, with interest of \$49.1 million, most of which has already been encumbered.

The Committee also received a report of the Performance Audit conducted for the 2006/2007 fiscal year by Mr. Royce Townsend of Vavrinek, Trine, Day & Co., LLP. The Committee was pleased to hear that the audit report included no exceptions, which clearly demonstrates that the District is managing the Measure M program effectively and in accordance with all evaluated performance criteria.

Mr. Chapko provided an overview of all of the projects currently under construction. Several projects are in the final close-out stage and bid openings were scheduled for Measure M work at Marshall, Ramona, and Chino High School during this quarter.

The Committee's Second Quarterly Report was presented to the Board of Education on February 7, 2008 by Ms. Allen.

## CITIZENS' BOND OVERSIGHT COMMITTEE MEETING MINUTES January 14, 2008

**Call to Order**: Ms. Allen called the meeting to order at 5:07 p.m.

Ms. Chen introduced Mr. Chapko, the new Director of Maintenance, Operations, and Construction, to committee members.

#### 7. Construction Update/Change Orders

Mr. Chapko provided an overview of the projects under construction. He informed the committee that projects at Chino High School stadium, Don Lugo modernization, Cortez, Dickson and Buena Vista modernizations are in closeout and scheduled for board approval in the upcoming months. Bid opening for the Marshall and Ramona Measure M work is scheduled for January 31, 2008. Bid opening for the renovation work at Chino High School is scheduled for February 20, 2008. Construction for both bids will follow shortly after bids have been approved by the Board.

Change orders were distributed via email. Members were encouraged to forward questions to the committee chairperson, Ms. Allen.
