Scope: Relocation of existing Relocatable Classrooms including site utilities and asphalt walkways. Construction of a new 12,000 sf classroom building including restroom facilities.

Status: The contract completion date was extended from March 6, 2009 to March 20, 2009 due to additional work for the sewer line installation. Meadows continued construction of the new Classroom Building with the following activities: The sewer connection at Philadelphia Street and on-site was completed, asphalt paving at the street and ball walls was completed, site concrete was completed, landscaping was completed, flooring was completed, plumbing fixtures in restrooms were installed, HVAC units are operational and the building is climate controlled. Remaining work to be completed: Installing countertops, plumbers are setting sinks inside classroom countertops, testing fire alarm system. Finish and testing data drops, interior/exterior speakers and telephones lines. Establish communication with Energy Management System ('EMS') with HVAC units. Final roofing coats, weather permitted. Bldg. K will be occupied on January 26, 2009.

Scope: Modernization of Locker Room Building. Construction of a new 8,200 sf classroom building.

Status: Meadows continued construction of the new Classroom Building with the following activities: Next to Bldg. E, Southern California Edison ('SCE') installed a new electrical transformer, the school's Main Distribution Switchboard ('MSD') equipment was removed and replaced, Bldg. X was energized, HVAC units are operational and the building is climate controlled, fire alarm was tested and completed, speakers and telephones lines were completed, data drops were completed. Projection screens were installed, interior and exterior sides of windows were caulked, interior and exterior painting was completed. Remaining work to be completed: Defective steel doors were removed and replaced with temporary wooden doors, new steel doors will be installed in 3 weeks. Installation of projector mountings, concrete pours East of Bldg. X., establish communication with Energy Management System ('EMS') with HVAC units. Final roofing coats, weather permitted. Bldg. X will be occupied on January 20, 2009.

Scope: Modernization of classrooms and ADA upgrades to restrooms and site.

Status: KAR completed Phase 3 (Bldg. B). During the winter break classrooms 17, 18, Attendance and Xerox rooms were completed. Also, fire alarm upgrades in the following buildings were tested and completed: Weight room, Gym, Boys and Girls Locker rooms, Pool rooms and Student store. KAR continued construction with Phase 4 (Bldg. P-Music Room) which includes the following activities: Existing flooring has been removed, demolition at the boys' and girls' restrooms, removal of interior and exterior concrete stairs, preparing for interior painting, and began installing fire alarm pathways. Remaining work to be completed: Remove existing doors at various locations, rough-in plumbing at restrooms, pour new exterior concrete stairs and new concrete slabs, new flooring, and install new door frames and doors. Phase 5 is scheduled to begin during the summer of 2009.
