

May 13th Booster Meeting Minutes

- Review of minutes from April 8th meeting-not approved
- **Amendment for April 8, 2024 meeting**=EachTeam gets one representative to vote(can be coach or parent representative). Melinda expressed concern about how some coaches vote throughout the year and others do not, but when it comes to voting for the executive board, everyone wants to vote. Coaches need to be consistent when placing votes.

- Presented the fireworks booth (version 1) and coaches want to keep booths the same and gave reasons for it. Against the original presentation of team change. (gave version 2 to coaches)

- Hinkle gave a history of the fireworks booth and revenue change
- Hinkle is trying to find money for all sports and in this we talked about each coach having a budget for their team. This would also include banners, trainer, insurance and equipment for team

- Summer athletic trainer-AT Vantage approved \$72-75/hour 6 hours a day M-th
- Miller: To him the room is very tense. Asked if we had norms to refer to before each meeting. We should be building up each other, not putting each other down.

Jeannette reassured parents and the board will relook at requirements.

- London Gibbs-expressed that everyone works hard and looking at unweighted GPA's and how Spring sports go through 3rd grade check
- Miller went on to explain the why of AP classes and how they are scheduled. Also said that schools are moving out of the top 25 and moving to 4.0 or above.
